

Chapter-3, Clause No. (ii) (Page No. 6) (The Vendor should have at least 5 Nos. of Vehicles registered in his name / Firms Name with Commercial/Taxi Registration not older than 1st-December-2018)	In my last five years of experience I have observe that every department in their tender clearly say that vehicle should not be older than 2 & 3 years. For bidders not possible to purchase every time new vehicle. So in the view of the terms of tender documents Bidders outsource the vehicle from market for supply the vehicle in concern of the department. So I request to you that please remove the clause no(ii) of tender document in page no. 6.	The Vendor should have at least 2 Nos. of Vehicles registered in his name / Firms Name with Taxi Registration not older than 1st-December-2017
2.	Chapter-3, Clause No. (vii) (Page No. 6) (The Bidder/Travel Agency should have Head/Branch office in Patna with basic infrastructure)	I would like to assure you that if I qualified in financial bid I will open an office in Patna.	Qualified firm (doesn't have office in Patna) may open an office in Patna. Work Order will be given to such Firm after getting related documents in this regard.
3.	Chapter-5, Terms and Conditions, Performance Security (The vendor needs to deposit a Performance Bank Guarantee @5% of estimated Contract Value)	For MSME vendor security deposit is 20% of non MSME vendor. It is clearly said in Bihar Purchase Policy Act-2002.	The micro small and Medium Enterprise (MSME) units has to submit only 20% amount of the performance Security of non MSME Enterprise. Bids of MSME should be accompanied by valid certification from MSME.
