


The Corrigendum-IV is being issued in response to queries raised with regard to changes made through Corrigendum-III.

However, for all positions described in Annexure-II of Corrigendum-III, the age limit shall be as follow.</p> <ul style="list-style-type: none">• Upper Age limit for Executive Engineer shall be 50 years and,• Upper age limit for Assistant Engineer shall be 45 Years• Age limit for rest all positions shall be minimum 21 years and maximum 40 years. <p>Cut-off date for all positions shall be 1st January of the year of advertisement. Relaxation for age limit for reserve category will be as per Government of Bihar of norms.</p>
